## Respected Sir/ Madam,

This is with reference to your announcement on digital portal and email received dated August 04, 2022, seeking clarification on the announcement submitted on 04.08.2022 informing about general updates. We hereby submit our response as follows:

Response to NSE:

1. Expected quantum of loss/ damage caused;

**Response-** The approximate amount of expected loss/damage due to the incident is Rs. 60 Lacs. There was damage of Furniture and Fixtures of the Laboratory including the QC Lab Equipment and some glass windows and glass doors of the Factory Premise.

2. Whether loss/damage covered by insurance or not including amount;

**Response-** Yes. The company has insured the Factory Building and its Plant and Machinery with stocks and Furniture-Fixtures under Fire & Peril Insurance Policy with HDFC ERGO General Insurance Company Ltd. and the sum insured under the Policy is amounting to Rs. 12,175 Lacs.

We already informed vide our Intimation letter to NSE dated 03.08.2022 about it that the loss/damage covered by insurance as the Factory building including Plant and Machinery was covered under Fire & Peril Insurance Policy so it was immediately informed to the Insurance Company and procedure for claiming loss was initiated.

There is no disruption/adverse impact on the production process due to the incident. Hence the Production work being started immediately from August 04, 2022.
