A. Date, Time and Venue of the Annual General Meeting:

The meeting commenced at 11.00 a.m. (IST) and concluded at 01.00 p.m. (IST).

B. Proceedings in Brief:

Mr. Manhar Jivanbhai Sanspara, Chairman, chaired the meeting.

The requisite quorum being present, the Company Secretary with the consent of Chairman called the Meeting to order.

The Company Secretary informed that remote e-voting commenced at 10:00 a.m. on Tuesday, September 26, 2023 and concluded at 5:00 p.m. on Thursday, September 28, 2023.

The following items of business as set out in the Notice convening the 14th Annual General Meeting were commended for members' consideration and approval:

Ordinary Business

- Adoption and consideration of the Audited Financial Statements of the Company for the Financial year ended on March 31, 2023 and the Statement of Profit and Loss for the year ended on that date and the Reports of the Board of Directors and Auditors thereon.
- Appointment of Mrs. Maya Dinesh Sanspara (DIN: 07601393), Non-Executive Director, and Mr. Mahesh Vallabhbhai Mavani (DIN: 02623368), Executive Director, retiring by rotation.

The Company Secretary also informed the members that M/s. Dhirren R. Dave & Co., Company Secretaries, was appointed as the scrutinizer to scrutinize the voting through electronic means (i.e., remote e-voting) and voting at the meeting by Postal Ballot.
